Brief description of task or project:

The Club racing and sailing event programme has been severely affected by the Covid-19 infection and the need for people to minimise physical distance. From July 4th restrictions are lifted to allow at least some activity to take place, the Government guidelines are not clear and are still open to some interpretation. Nevertheless this will allow a limited Sailing Programme to take place. This document sets out how this will be done at CCSC, and how the risk of transmitting the virus will be minimised.

- The Club house remains closed and may be accessed only with permission from the GC and a safe way of working as detailed in a method statement (like this document)
- A physical distance must be maintained between people not living in the same household. From 4th July 2m 'social distancing' is recommended but this may be reduced to 1m+ in outdoor areas as highlighted in yellow below.
- Surfaces that have been touched and therefore might provide a source of transmission of the virus need to be wiped after use.



- Bag to be provided for used wipes to be stored until disposal
- Additional Shore side duty Beach person to count boats out and in, advise OD and keep watch from shore.
- Race team must be aware that the Ferry is not available to be called on
- Portland Harbour Authority and WPNSA to be advised of revised sailing programme (permission granted)
